## **Weed & Pest Control in Trees & Amenity Sites**

# **Amendments - July 2016**

#### Introduction

When Weed & Pest Control was published in 2007, when many of the changes to pesticides were anticipated and included in the publication which remained largely up to date for many years. However, following the increased rigour introduced as a result of the 2009 EC regulation, the pace of change has accelerated dramatically - particularly during 2015 and 2016. A a result, the following notes provide an update on these changes in advance of a planned revised publication in 2017.

Note that the following comments relate to UK approvals - there may be some differences in Ireland. The amendments are provided in two sections:

# 2.1 The Basics

Page 1. Offlabel SOLA's now renamed EAMU's (Extension of Use for Minor Uses)

Page 2. i. The statutory box has been removed on most labels

ii. Hazard warning symbols have changed from the European system to the Global system. As a result the Maltese Cross has been replaced by two new symbols.

Page 6. The "Grandfather Rights" for those born before 31/12/84 have been withdrawn. All spray operators need to have the appropriate certificate irrespective of age.

Page 9. i. The Maltese Cross symbol has been replaced by two Torso symbols.

ii. Many changes to PPE requirements - check the current labels

iii. The following herbicide approvals have changed:

amitrol - withdrawn asulox - emergency approval only dichlobenil - withdrawn fluroxypyr - no "tree" approvals MCPA - no hand held use mecoprop-P - no "tree" approvals

oxadiazon - withdrawn picloram - withdrawn propaquizafop - no tree approvals triclopyr - withdrawn

Page 10. i. Many changes to PPE requirements - check the current labels.

Mahkteshim has been renamed Adama.

Scotts became Everiss, and now ICL.

Syngenta is now Chinese owned.

Many products mentioned have been withdrawn or no longer have "tree" approval.

- Page 16. Contest & Agritox Dry have been withdrawn. Products such Gazelle SG, Eagle and other sulfonuryl uerea herbicides are formulated as Water Dispersible Granules. Casoron G has been withdrawn.
- Page 18. Dichlobenil & triclopyr have been withdrawn.
- Page 20. Paraquat and dichlobenil (Casoron G) have been withdrawn.
- Page 22. Triclopyr is no longer available other than in mixtures. Fluroxypyr and propaquizafop no longer have approvals in trees.

# 2.2 Herbicides

- Page 33. Amitrol, picloram, dichlobenil, oxadiazon & triclopyr are no longer available
- Page 34. Amitrol has been withdrawn
- Page 35. Asulam has an Emergency Approval for the control of bracken only. Knapsack use severely restricted and no offlabel use in Christmas trees.
- Page 37. 2,4-D aquatic use has been withdrawn.
- Page 38. 2,4-D + picloram has been withdrawn.

Page 39. Dicamba now available under the trade name of

- Page 40. Dichlobenil has been withdrawn
- Page 42. Fluazifop-p-butyl may no longer be applied by hand held equipment Previous fluroxypyr farm woodland & Christmas tree offlabel approvals (Starane 2 & Tomahawk) have been withdrawn, but Starane XL may be used in Christmas trees.
- Page 43. Glyphosate (biactive). Roundup Pro Biactive has been withdrawn & replaced by Roundup ProActive.
- Page 44. Isoxaben has been reformulated & sold as Flexidor (no 125) & is 4x strength.
- Page 45. MCPA may no longer be applied by hand held equipment Mecoprop-P no longer has offlabel approval in farm woodland or Christmas trees
- Page 46. Metazachor rate reduced from 2.51/ha to 1.51/ha & use restricted to 1 year in 3.
- Page 47. Oxadiazon has been withdrawn.
- Page 48. Pendimethalin also available as preferred formulation Stomp Aqua. Picloram has been withdrawn.
- Page 49. Propaquizafop no longer has any approvals in trees. Use Laser instead.

  Triclopyr is now only available in mixtures, none of which have approvals in trees.
- Page 52. All these products have been revoked and withdrawn.
- Page 53. All these products have been revoked and withdrawn.
- Page 54. Fluazifop P butyl may not be applied by hand held equipment Falcon has no longer approval in trees.

  Dichlobenil has been withdrawn.
- Page 56. Dichlobenil & oxadiazon have been withdrawn
- Page 57. Dichlobenil, oxadiazon and paraquat/diquate have been withdrawn Previous fluroxypyr farm woodland & Christmas tree offlabel approvals (Starane 2 & Tomahawk) have been withdrawn, but Starane XL may be used in Christmas trees.
- Page 58. Asulam may no longer be used for dock control 2,4-D+dicamba+triclopyr & fluroxypyr no longer have approval for use around trees. Dichlobenil has been withdrawn.

#### 2.3 Weeds

- Page 59. **Bindweed.** Picloram & picloram+2,4-D have been withdrawn. MCPA no hand held use. **Bracken.** Asulam available under Emergency Approval. Knapsack use restricted. Dichlobenil & picloram have been withdrawn.
- Page 60. **Buttercup.** MCPA Knapsack use prohibited. Picloram & picloram + 2,4-D revoked. **Clover.** Mecoprop-P offlabel approvals in trees have been withdrawn. Picloram & picloram + 2,4-D have been revoked.

  Nu-shot & Broadsword replaced by Broadshot with grassland approvals only.
- Page 61. **Dandelion**. MCPA Knapsack use prohibited. Picloram & picloram + 2,4-D revoked. Previous fluroxypyr farm woodland & Christmas tree offlabel approvals (Starane 2 & Tomahawk) have been withdrawn, but Starane XL may be used in Christmas trees. **Dock.** MCPA Knapsack use prohibited. Picloram & picloram + 2,4-D revoked. Previous fluroxypyr farm woodland & Christmas tree offlabel approvals (Starane 2 & Tomahawk) have been withdrawn, but Starane XL may be used in Christmas trees. Dichlobenil has been withdrawn. Asulox has emergency approval for bracken only. Mecoprop-P offlabel approvals in trees have been withdrawn.
- Page 62. **Hawkweed, Hawkbit.** Knapsack use prohibited. Picloram & picloram + 2,4-D revoked. Previous fluroxypyr farm woodland & Christmas tree offlabel approvals (Starane 2 & Tomahawk) have been withdrawn, but Starane XL may be used in Christmas trees. Nu-shot & Broadsword replaced by Broadshot with grassland approvals only. Mecoprop-P offlabel approvals in trees have been withdrawn. **Himalayan Balsam.** 2,4-D found to be largely ineffective.
- Page 63. **Hogweed.** Picloram has been revoked.
  Flurasulam (Boxer), imidosulfuron (Eagle) and metsulfuron methyl (Jubilee SX) all have offlabel approvals in Christmas Trees and all provide useful control. **Giant Hogweed.** Picloram (Tordon) and triclopyr (Timbrel) have been withdrawn.
- Page 64. Limited control from 2,4-D. Amitrole and dichlobenil have been withdrawn. **Japanese Knotweed.** Nu-shot & Broadsword replaced by Broadshot with grassland approvals only. Picloram has been withdrawn.

- Page 65. **Nettle.** Picloram & picloram + 2,4-D have been revoked. MCPA Knapsack use prohibited. Triclopyr (Timbrel) has been withdrawn.

  Nu-shot & Broadsword replaced by Broadshot with grassland approvals only. Previous fluroxypyr farm woodland & Christmas tree offlabel approvals (Starane 2 & Tomahawk) have been withdrawn, but Starane XL may be used in Christmas trees. **Plantains.** Picloram & picloram + 2,4-D have been revoked. MCPA Knapsack use prohibited. Nu-shot & Broadsword replaced by Broadshot with grassland approvals only. Dichlobenil has been withdrawn.
- Page 66. **Ragwort.** Picloram & picloram + 2,4-D have been revoked. MCPA Knapsack use prohibited. Nu-shot & Broadsword replaced by Broadshot with grassland approvals only. Dichlobenil has been withdrawn. Mecoprop-P offlabel approvals in trees have been withdrawn. Dichlobenil has been withdrawn.
- Page 67. **Thistles.** Picloram & picloram + 2,4-D have been revoked. MCPA Knapsack use prohibited. Nu-shot & Broadsword replaced by Broadshot with grassland approvals only. Dichlobenil has been withdrawn. Mecoprop-P offlabel approvals in trees have been withdrawn. Dichlobenil has been withdrawn. Clopyralid Vivendi also has approval for use in Christmas trees.
- Page 68-73. **Scrub Control.** Currently only glyphosate has approval for use on scrub around trees. Timbrel has been withdrawn & 2,4-D+triclopyr+dicamba is now restricted to grassland, so no products containing triclopyr have approvals around trees.

## 2.4 Insecticides, Fungicides, Growth Regulators and Rodenticides

- Page 74. All organophosphorus insecticides (chlorpyrifos & dimethoate) have been withdrawn. The synthetic pyrethroid insecticide bifenthrin and the acaricides fenpyroxymate (Sequel) has been withdrawn, and tebufenpyrad (Masai) no longer has offlabel approval in trees.
- Page 75. Bifenthrin has bee withdrawn
- Page 76. No post planting approvals for alpha-cypermethrin. Use as a nursery applied treatment only.
- Page 77. Chlorpyrifos has been withdrawn.
- Page 78. Deltamethrin may no longer be applied by knapsack sprayers
- Page 79. Dimethoate has been withdrawn.
- Page 80. Fenpyroxymate (Sequel) has been withdrawn.
- Page 81. Pirimicarb (Aphox) no longer has offlabel use in Christmas trees.
- Page 82. Tebufenpyrad (Masai) no longer has approval for mite control in Christmas trees
- Page 83. Prochloraz withdrawn
  Tebuconazol be careful. Use for rust control in Nordmann Fir as resulted in needle damage.
  Urea now classified as a "Basic Substance".
- Page 84. Warfarin Grey Squirrel Bait has been withdrawn.
- Page 85. Tipoff has been withdrawn. Offlabel approvals for ethoxyfen (Cerone) and NAA (Fixor) provide alternatives for leader control in Nordmann Fir Christmas trees.

## 2.5 Forestry & Christmas Trees.

- Page 87. Dichlobenil (Casoran) & paraquat (Gramoxone) have been withdrawn. Propaquizafop (Falcon wrongly named Laser) no longer has approval in trees.
- Page 88. Diclobenil (Casoron) & triclopyr (Timbrel) have been withdrawn. Asulam has Emergency Approval for bracken only. Dicamba+2,4-D+triclopyr (Broadshot) now has grassland approvals only.
- Page 89. Table 29. Fluazifop-P butyl (Fusilade Max) currently may be used (2016) in Christmas Trees and Farm Woodlands under the Long Term Arrangements which are being discontinued. Knapsack use prohibited.

Propaquizafop (Falcon) no longer has approval in trees.

Table 30. Oxadiazon (Ronstar) has been withdrawn.

Page 90. Table 31. Asulox approved under Emergency Approval for bracken only.

Dicamba + mecoprop-P. All dicamba based products currently may be used (2016) around trees under the Long Term Arrangements which are being discontinued.

Table 32. MCPA may no longer be applied by had held equipment.

Mecoprop-P no longer has approval in trees.

- Fluroxypyr has no approval in farm woodlands.
- 2,4-D+dicamba+triclopyr (Broadshot) no longer has approval in trees.
- Page 92. Dichlobenil (Casoron) & triclopyr (Timbrel) have been discontinued.
- Page 93. Isoxaben (Flexidor 125) now reformulated as 4x strength (500g/l) Flexidor. Clopyralid (Dow Shield) now reformulated as double strength rates now 250 375ml/ha.
- Page 94. Amitrole (Weedazol) and paraquat (Gramoxone) have been withdrawn.
- Page 95. Asulam (Asulox) no approval for docks. 2,4-D (Depitox) and propaquizafop (Falcon)- approval withdrawn for this use. Paraquat (Gramoxone) has been withdrawn.
- Page 96. Alpha-cypermethrin (Contest) has been withdrawn. Alternatives for the control of Hylbius include acetamiprid (Gazelle SG), and imidacloprid (Merit Forest pre planting only).
- Page 97. Asulam (Asulox) Emergency Approval excludes Christmas trees. Oxadiazon (Ronstar & triclopyr (Timbrel) have been withdrawn.
- Page 98. Asulam (Asulox) not approved in Christmas trees under the Emergency Approval.

## 2.6 Insect Pests

- Page 99. **Aphids.** Decis can no longer be applied by knapsack sprayers. Use lambda cyhalothrin (Hallmark).
  - **Conifer Spinning Mite.** Tebufenpyrad (Masai) no longer approved in Christmas trees. Use abamectin (Dynamec), spirodiclofen (Envidor) or a sulphur programme.
- Page 100. **Sawfly & aphids.** Decis & Decis Protech can no longer be applied by knapsack sprayers. Use lambda cyhalothrin Hallmark).
  - **Rust Mite.** Tebufenpyrad (Masai) no longer approved in Christmas trees. Fenpyroxymate (Sequel) has been withdrawn. Use abamectin (Dynamec), spirodiclofen (Envidor) or a sulphur programme.
- Page 101. **Balsam Woolly Aphid.** Decis & decis Protech can no longer be applied by knapsack sprayers. Use lambda cyhalothrin (Hallmark). Dimethoate (Danedim) has bee withdrawn.

## 2.7 Amenity

- Page 102. **Amenity Vegetation Residual Herbicides.** Dichlobenil (Casoron) & oxadiazon (Ronstar) have been withdrawn.
- Page 103. **Public Access.** Dichlobenil, paraquat and triclopyr have all been withdrawn.
- Page 104. Roundup Biactive has been replaced by products such as Roundup ProActive Dichlobenil has been withdrawn.
- Page 105. **Amenity Grassland.** MCPA & mecoprop-P may no longer be applied through hand held equipment.
- Page 106. **Aquatic Weed Control.** Approval for 2,4-D (Depitox) has been withdrawn. Dichlobenil (Casoron) has been withdrawn.
- Page 107. **Total Weed Control.** Now called "Land Not Intended for Cultivation". Amitrole (Aminotriazol Technical), asulam (Asulox), 2,4-D + piclorame (Tordon 101), picloram (Tordon) and triclopyr (Timbrel have all either been withdrawn or this approval revoked. Flazasulfuron (Chikara) has approval for this use.
